## **RULES & REG'S**

#### **GENERAL GUIDELINES**

- The Lost Sierra Chamber of Commerce reserves the right to accept or decline applications at our discretion.
- Beer and Food vendor spaces are flexible in size depending on needs.
- Retail and Info booth spaces are 10' x 10'
- Vendors are responsible for obtaining and displaying any event permits as required and operating within any local, state, or federal guidelines or laws.
- Vendor to provide tents, tables, chairs, weights (if needed), and displays. While the park is fairly level, the ground may not be completely level, bring leveling devices for displays. This is an outdoor event; be prepared for all types of weather.
- Vendors must be set up prior to llam and remain open for the entirety of the event. No early closures.
- Vendors must maintain a clean area and return their areas to pre-event condition..
- No vehicles of any type may be driven on the grass or sidewalks or parked on or near exhibitors' assigned locations **during the event**. Vehicles will have easy access for set up and tear down and will be directed to close secure parking for the duration of the event.
- Vendors selling food must be current with CA Health and Sellers Permits (Please send copy with application)
- All beer/wine/liquor sales must be through the chamber. More information on alcohol sales available by contacting Erin Wallace (860) 268-7048

#### **TIMELINE**

OCTOBER 20- Deadline for vendor application OCTOBER 28 - Railroad Days Revival 7 AM - Event Setup begins 11:00 AM - EVENT BEGINS 5:00 PM - EVENT ENDS

This agreement shall be binding on the parties hereto, their successors, or assigns. It is agreed that neither party may convey, sell or assign this AGREEMENT without express written consent signed by both parties. This agreement shall be construed under the laws of the State of California and actions hereunder shall be in Plumas County, California. Failure to comply with this AGREEMENT shall entitle to terminate this AGREEMENT and to demand the immediate cessation of VENDOR activities, removal from the festival grounds, and forfeiture of any fees and deposits. The first notification shall constitute a warning; the second notification shall result in forfeiture of the deposit; the third notification may result in the termination of this AGREEMENT and removal of the VENDOR from the festival grounds.
